ORDINANCE NO. 2016-05

**AN ORDINANCE OF WILLIAMS TOWNSHIP AMENDING THE
WILLIAMS TOWNSHIP ORDINANCE NUMBER 1989-2 MOVING
PERMITS BY REQUIRING ALL PERSONS TO INCLUDE THEIR SOCIAL
SECURITY NUMBER ON THE PERMIT APPLICATION.**

WHEREAS, Williams Township is a second class township organized and operating under the laws of the Commonwealth of Pennsylvania; and

WHEREAS, on May 11, 1989 the Williams Township Board of Supervisors adopted Ordinance No. 1989-2 requiring all persons to obtain a moving permit if they are moving in or out of Williams Township; and

WHEREAS, the Williams Township Board of Supervisors wishes to amend Ordinance No. 1989-2 to require all persons to submit on their moving permit application their social security number in order for the earned income tax collector to verify that the proper taxes are being paid to Williams Township.

NOW, THEREFORE, the Board of Supervisors hereby *ORDAINS*, as follows:

SECTION I. AMENDMENT.

Ordinance No. 1989-2, Section III, Subsection A is hereby amended to read as follows:

SECTION III. REPORTS BY PERSONS.

A. Application shall be made to the Township Secretary (or designee) setting forth his or her name and present address, the number of school age children moving with the Applicant, the proposed or new address, names or names of owners or reputed owners of both properties (present and proposed), the names of all persons included in the move and the social security numbers of all persons included in the move.

SECTION II. REPEALER.

All ordinance or parts of ordinances which are inconsistent herewith are hereby repealed.

SECTION III. SEVERABILITY.

If any section, paragraph, sub-section, clause or provision of this Ordinance shall be declared invalid or unconstitutional by a court of competent jurisdiction, such decision shall not affect the validity of this Ordinance as a whole or any part thereof other than that portion specifically declared invalid.

SECTION IV. EFFECTIVE DATE.

This Ordinance shall become effective five (5) days after final enactment.
