### **Comments**

On September 29, 2023, the PA Department of Environmental Protection ("Department") conducted a routine complete

inspection at Chrin Bros. Sanitary Landfill ("Chrin"). Representing the Department was Amy Faulch ("this inspector"). Joseph Klobusicky provided a site tour and was interviewed on behalf of Chrin. Williams Township host municipality inspector Joseph Black was also present for this inspection. See the 9/29/23 odor patrol log for weather details.

The following Department personnel entered the landfill since the last inspection: A. Faulch and E. McNulty on 8/1/23; M. Glogowski on 8/16/23; C. Harding on 9/18/23; M. Glogowski on 9/20/23; M. Vipond on 9/20/23; R. Mullin on 9/21/23; and A. Faulch on 9/29/23.

#### SITE TOUR:

Prior to entering Chrin, this inspector conducted an odor patrol in the areas surrounding the facility. A moderate, persistent gas odor was detected along Morvale Rd. between Industrial Dr. and Wottrings Mill Rd. See the 9/29/23 odor patrol log for details.

During the site tour, this inspector observed the working face in 9B. One truck was unloading. A moderate trash odor was detected to the west of the working face, and a strong trash odor was detected to the SW of the working face. A crew was digging out around a gas line just east of the working face, which may have been contributing to the trash odors observed in this area. Two spray bar misters were in operation to the south of the working face, perimeter line misters were in operation and the water truck was being swapped out at the working face at the time of this inspection. The former working face area at the east end of 9B showed some waste flagging and needs additional cover. The slope above 9B was graded, and was awaiting seeding at the time of this inspection.

A gas odor was detected along the southwest access road at the time of this inspection. Mr. Klobusicky stated that a gas line was recently hit in an area above 3D and was being repaired. Flare 4 was also offline for a while yesterday, but was running at the time of this inspection. The 3E waste relocation project is continuing, and waste is still being relocated to the working face, however none was being sent at the time of this inspection. The bottom slopes of 3D/3E have been graded and were waiting for final cap and seeding. A truckwash was in operation on the north access road. The 501 building is being demolished and all maintenance operations have been moved to the new maintenance building across Industrial Dr.

Flare 4 was in operation during this inspection with a temperature of 1710°F and a flow of 1675 scfm. Flare 3 and the

candlestick flare were not in operation. Engines for the gas-to-energy plant were being refurbished, and Chrin is preparing to submit a permit application for the plant.


